The Child & Family Center uses the Household Size-Income Statement (Child and Adult Care Food Program) to gather family income information to determine each family's tuition. Families choosing not to complete the form will be charged at the Full Tuition Rate.

Additional Information

- An initial registration fee per child to confirm initial enrollment is required. The **nonrefundable registration fee** is **\$40** for Madison College Students; and **\$50** for Madison College Faculty/Staff and community families. Note: for enrolled MMSD 4K families, this will also cover the District-required materials fee.
- For subsequent academic terms, an enrollment continuation fee of **\$10** for Madison College Students and **\$15** Madison College Faculty/Staff and community families will be assessed.
- Based on income, families may be eligible for a fee waiver. Please discuss with the Center administration staff.
