Veteran Benefits Suspension Appeal

INSTRUCTIONS - Madison College understands that unfortunate and unavoidable circumstances occur and affect student performance. Veteran students may request an appeal of their veterans benefits suspension for the following term if reasonable circumstances existed that caused the suspension.

A reasonable appeal would include the following:

- Illness or death in student's family
- Illness or injury to student
- Unavoidable change in student's employment
- Immediate family or financial obligations beyond student's control
- Unanticipated difficulties with childcare or transportation arrangements

If the appeal is granted, it is for the following term during which time the student will need to achieve a grade of "C" or better in each class for the term following suspension.

Completion of this form does not guarantee that the appeal will be granted.
